All personal information included in this Release will not be made publicly available, but may only be used by Photographer/Filmmaker and his/her Assigns in connection with the distribution and licensing of the Content where necessary (e.g., to defend claims and protect rights), may be retained as long as necessary to fulfill this purpose (according to Art. 6 Sec. 1 GPDR), and transferred to countries with different data protection and privacy laws where it may be stored, accessed and used. Any data processing by EyeEm will be executed according to the EyeEm Privacy Policy.
