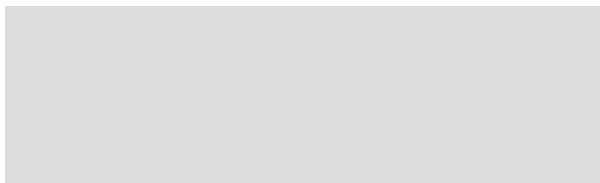
I represent and warrant that I am at least 18 years of age and have the full legal capacity to execute this Release on my own behalf, or on the behalf of the corporate owner.
